Ticket collector in railway has legal duty of checking the tickets of passenger but it is not binding on him to help a Senior citizen in getting a seat or helping them to carry luggage.



(a) Why did philosopher say so?


(b) 'Change is less about the external world or manifestation but about internal transformation'. Comment. (75 Words Each) (10 Marks)

Q7. According to you what is conflict of interest? If you are working as a software developer in XYZ Company and at the same time you are working as freelancer for some start-up/small organisation, will that be called as the conflict of interest? Will that be called unethical according to professional ethics? Explain. (150 Words)(10 Marks)

When a person has his own personal interest in a decision taken for public, organisation then there is conflict of interest. Railway minister giving contract to his relative instead of having other contractor who has quoted less amount is an example of it.

It is conflict of interest if a software developer in XYZ company breaching the contract of the company works for another start-up. In this case he may use experience and knowledge/resources ^{gained} in XYZ company for the benefit of other start-up. If the start-up is non-software or if he is not using the company's resource to do freelancing then he should get permission from company's management before undertaking any task of other company.

Even if it is ~~not~~ ^{un}ethical if a person helps small organisation to grow which can eventually become competitor of XYZ company. A person drawing salary from one company ethically shouldn't work

for the interest of another company. ~~best~~ If he/she is working for an organisation which is ~~not~~ ~~a~~ ~~threat~~ small/^{his} or any startup then ~~it's better~~ he should quit from his previous job.

A Software developer can use the resources, Code, may not totally focus on his current job ~~totally~~ as he is working in multiple organisation. Hence it is unethical & also conflict of interest if a person works for multiple organisation at the same time and drawing money from both.

The decision of municipal Commissioner should be based on overall public benefit & need to be taken quickly.~~

~~§ Person needs to have self-restraint from the external allurement which is unethical. An employee of a Software Company or bank has access to the confidential information. There can be monetary or other allurement to leak such information. In case of lack of self-restraint it is easy to fall for such allurements which is unethical.~~
