Though these measures did not prove much effective but they had made corruption a crime. In today's conditions much more is needed than to have stringent laws. Laws will only be successful when we have a strong moral character of our public and government officials.

### LESSONS


This learning lessons from the life is an important component of evolutionary process. Though we never reach the perfection ever, but
