



Post-truth is a phenomenon, which has come to prominence in recent days. It involves the alteration interpretation of facts and figures to suit the narrative of a particular view and to bolster their opinion. It seeks to mislead, or atleast not give the complete picture to the general public so as to not make a rational decision.

Post-truth drives the people to act on the basis of emotion without verifying the veracity of the data given. In the age of information technology and the internet; there is a treasure trove of data available in an instant. The problem is how to authenticate the information being presented. With increasingly short attention spans of the public and the need to sensationalise the matter at hand and more importantly to control the narrative of the issue, post truth becomes deadly in the hands of the wrong persons.

This phenomenon plays on places an enormous amount of power in the hands of the fabricator. The fabricator to now has the motive and the ability to either sensationalise the issue, rile up the masses or he can dress up the issue as an unimportant phenomena and kill the issue at its bud.

Use of post-truth is not something new. In the past Bismarck made ample use of it, in needling the French during the unification of Germany. Again during the World War II, Nazis used this weapon to suit their narrative of Gew Hegemon. It was Goebbels the Nazi propaganda chief who said that if one lie was repeated again and again and again that people will be inclined to believe that there must be something to it. It convinced the world to turn their back on the horrors of the holocaust.

And not just in the political world, even

In the world of science, facts can be distorted to make something appear the way they want it to. For example, the anti vaccination campaign handled by the professionals who claimed that there is a link between autism and vaccination, using a data outlier. This put off many people from vaccinating their children, with the catastrophic result of being a reducing herd immunity and developing diseases which were once life threatening.

In the environment, we see, post truth has been used to control the narrative of the Climate change. There are many who believe that Climate Change as a phenomenon do not exist and they are done specifically to cripple the economies of the West and curb their productivity. There are people who believe that short term gain outlives long term destruction.

More recently in the case of Brexit, we saw that the narrative of the United Kingdom paying more than its fair share and the

immigration vices fuel the narrative and the debate. Finally culminating in the UK leaving the EU.

These examples show the power that a certain narrative hold to the people. This gives liberty to the powerful manipulator to use those facts for the person's own agenda. There are many reasons why post truth is extremely palatable to the people. The main is attraction being it plays to the narrative of the majority. It confirms their belief in what they hold to be safe and correct.

It gives license to them, to indulge in acts of a morally grey area. For example, refugee issue in Europe. The refugees are supposed to be treated with care and sensitivity and empathy. Instead with the narrative based on a minuscule portion of data, that they are there might be terrorists colors our entire outlook. Because of this, the entire refugees are refused asylum and turned back.

to the country that they have fled. Normally people even though the thought of hosting so many refugees would be uncomfortable they would not have been turned back. But with the narrative that they are terrorists gave them license to turn the refugees away.

Post-truth satisfies the majority of the population it gives them a sense of satisfaction in their own actions. With the manipulation of data, they feel that they have taken the right path.

Mainly, it has sway and power because it gives the people a break from reality and sense of escapism. No one wants to hear that the world is ~~sinking under~~ the effects of climate change; that we are wreaking havoc on the planet and a drastic change in lifestyle is needed to save the planet. So in this scenario when a person pushes the fabricated narrative of how "Climate Change" is a hoax or how climate change can be good for the planet people cling to it as an escape from reality.

so the manipulator, fabricator has unlimited power at his disposal. If the fabrication continues, it might benefit them. The oil companies and fossil fuel companies recognized this in the 1970's when they suppressed data on climate change and instead encouraged further production of fossil fuels endangering the planet but enriching them economically.

In the current scenario, post-truth evolves mostly on social media, rather than being a mere tool for networking it has evolved into a forum where people can air their views. When information arises from a source that appears to be credible, it is bound to get noticed and passed around. It becomes unstoppable in certain cases. Hence today the power once exercised by the media is now shared by the social media. Today their power has been truly recognized.

The power of good press and PR has also been recognized. Today in the world of journalism, for every
