

Q1. Why it is, sometimes believed that feelings are better guide to action than reasons?
Critically analyze. (150 Words) (10 Marks)

① Feelings are the thoughts, emotions, running in our mind. It is sometimes believed that feelings are better guide to action than reasons.

② Because, in many cases our actions are determined by our feelings and emotions, not by reasons.

③ e.g. - a civil servant has the patriarchal feeling or attitude in him. So his actions may be guided by such feeling and he may discriminate against the women in his decision making.

④ This action failed to be guided by the reason which should have been gender equality and it should be reflected in decision making.

⑤ To overcome such issue, one should have control over his emotions, feelings, prejudices etc.

⑥ Because without such control, which can be termed as emotional intelligence, feelings will guide the action and it will be biased.

- (150 Words) (10 Marks)

(a) ① Virtues are the good traits of behaviour. e.g. love, beauty, kindness are some of the virtues. Virtue ethics deals with the ethical ^{point of view} ~~decisions~~ which are guided by virtues.

② Knowledge is simple learning which ~~broader~~ makes us aware of various issues.

③ It can't be equated with virtue as it is not necessary that a knowledgeable person will have virtues. e.g. - in mythology, Ravan was a full of knowledge, but virtue was missing in him evident from his evil acts.

(b) ① ~~Ex~~ Although evil or bad actions are result of ignorance, still educated people get indulge in white collar crimes.

② Because it is not necessary that an educated person will have virtues in him, because

education is controlled by external mechanisms whereas virtue is an inner conscience which controls our behaviour.

③ Failed-control leads to ~~lose~~ ^{loss} of self-control and hence emotions override our senses. e.g. -

① ~~Sense~~ "Sense of superiority" means ~~acting~~ ~~is~~ or dominating over others. "Sense of empathy" means the ability to feel others suffering. ② The best leaders don't act with a sense of superiority because it results of poor work culture and ~~det~~ feeling of detachment within a group.

② "Sense of empathy" helps the leader to feel the emotions of the members of his group. So, ~~they~~ ~~the~~ members become more attached to the leader and leadership becomes successful.

① Traits like sense of empathy are not obstacles to professionalism, teamwork, partnership etc, rather it enhances these behaviours.

③ Because empathy ~~too~~ within group brings more closeness and attachment resulting in better

- ① "Trustworthiness" implies that the ability to maintain the trust ~~which~~ or belief which a person or an organisation has, ~~give~~ ~~me~~ imparted on you.
- ② It is essential for a civil servant to maintain high degree of efficiency and honesty in his work.
- ③ e.g. - An army official has information of ~~areas and ammunition~~ arsenals of our country.
- ④ His trustworthiness deters him to open this information even in an adverse situation in view of national security.
- ⑤ EI ~~helps~~ ~~it~~ helps to strengthen one's emotion and self control, so that his decisions are not taken by the emotions, biasness ~~rather~~ rather by reason, conscience and wisdom.

You had a detailed consultation with people regarding a Citizen Charter for water supply services. Based on the requirement and expectations of people, you had a discussion with your subordinates who were little reluctant about the Charter but seeing your positive attitude they ultimately agreed. You committed some hurry in implementation of the Charter and noticed the following problems:

1. The quantum of water promised could not be ensured.
2. The quality of water did not improve.
3. One of your key functionaries went on a long leave and you did not get his replacement.
4. The entire blame on the failure of the Charter came on you.

Ponder over the situation and answer the following questions:

- (a) What were the reasons of failure of the Citizen Charter?
- (b) What should have been ideal course of action and why?
- (c) Draw a Citizen's Charter for this case.

In this case as the head of water supply Board, my job is to make available quality water to the people in my town. In this regard I discussed with people and started implementing the Citizen Charter for water supply services.

(a) But the reasons of failure of the Charter are discussed below.



Q14. You are a civil servant and posted at a place with multi-cultural and multi-identity population with one dominant majority group and a big minority group. There arose a dispute on setting up statues of their respective icons in the area, cross claiming the same space. Any casual or delay will cost huge as past history indicates of big conflicts. Election is round the corner so different interest groups are eyeing to reap the benefits and has tensed the environment. Answer the following questions:

- (a) What preventive steps would you take to stop flaring up of a brewing dispute?
- (b) If the dispute flares up and turns violent, what would be your quick measures to contain it?
- (c) How do you react when failure to pre-empt and contain such a situation leads to your suspension? (250 Words) (20 Marks)

In this case, there are chances that the dispute regarding setting up statues may take the form of communal violence. Also different interest groups are working to add fuel to the fire which may further worsen the situation. So as a civil servant my 1st job is to take preventive measures.

(a) In this regard I can take the following steps.

① I will try to pacify the various groups by having proper discussion with the groups.

② If needed, I can specifically start discussion with the leaders of both the groups who can help to make the situation under control.

③ They also should be made aware of the previous conflicts which resulted in less or great damage to both the groups, so that they may stay back ~~from~~ worsening the conflict.

④ The wicked/opportunity hunting people from various interest groups should be ~~looked into~~ found out and ~~strict~~ actions should be taken against them.

⑤ In spite of such efforts, if violence erupts, then following quick measures should be taken to contain it.

① ~~Proper police~~ It should, better have been preventive
 ② Required number of police forces should be step deployed as soon as possible to handle the law and order situation in the area.

③ ~~Vulnerable Arrangement~~ Priority should be given to vulnerable groups like women, children, old aged persons who mostly becomes the victims of such violence.

④ Road networks, railways is going near the area should be given special attention to minimise the harassment of travellers.

However, while carrying out relief and rescue operations, you find out that a select group of youth turns hostile, resorts to stone pelting against the soldiers and also using some violent methods. It disrupts relief operation. Force present on the occasion also retaliates and a few youth got injured in this incident. This further aggravates the situation. One powerful minister suspends two of your team members. Whole team is de-motivated: What options do you have to handle the situation?

(250 Words) (20 Marks)

As the officer in charge both relief and rescue operation, my prime duty is to ensure proper relief to the flood affected people and also rehabilitate the victims of the disaster.

But such activity is greatly affected by the ~~infect~~ ~~can~~ violence caused by the hostile youths.

In such situations, I can take the following steps to handle the situation.

① I will try to pacify the hostile youths by having proper ~~talk~~ discussion with the leader of their group.

② I will try to make them understand that in disaster situations like flood, such conflicts will further worsen the situation and the suffering of vulnerables will further increase without proper ~~relief~~ relief and rehabilitation, as these

are greatly affected, by such acts.

③ I will also ask the army officials to show liberal attitude towards the youths to pacify the situation.

④ In spite of such peaceful measures, if situation doesn't improve, I may seek additional army forces to handle the law and order situation strictly so the relief work goes on without any hardship.

Q17. An officer of middle level marketing and sales management of a public sector oil company has received frequent complaint about adulteration of diesel and petrol by some retailers of the area under his jurisdiction despite his warnings in the past against such wrongdoing. Subsequently one day, he goes for an inspection of one such retailer who is known for his political connections as well as local bulies. While trying to carry out his official duty, he was first prevented from entering into the premises of the retailer and when he insisted he was allowed to enter. He was offered bribe for not carrying out his duty but he declined. Undeterred, he insisted that as the marketing officer he should be allowed to carry out his duties in public interest and in the interest of the government firm which he represents. The musclemen of the retailer started abusing and roughing him up when he tried to inspect the facilities to ascertain adulteration. A brawl ensued. He was badly beaten up and fatally wounded. He lost his life while being taken to the hospital.

Answer the following questions:

- (a) Was the officer carrying the inspection at fault?
- (b) Despite his noble intention and dutifulness of the highest order, do you think that the officer handled the case immaturely? Why?
- (c) Had you been in his place, how would have you proceeded to carry out your duty?
- (d) What could be the solution for such problems of adulteration on a lasting basis?

(250 Words) (20 Marks)

In this case the issues involved are ~~illegal~~ adulteration of diesel and petrol

- ① Obeying bribe to an honest public sector official
- ② Abusing and roughing the official which is against his right to life and dignity
- ③ Loss of his life which is a grave crime

Here the officer carrying the inspection was not at fault, because

① The retailer, to whom he went for inspection was under his jurisdiction

② he also didn't accept bribe offered to him which shows his honesty and integrity.

② he even didn't bother the threat to his life by the muddemen which shows his commitment to duty

⑥ Although the intention of the officer was noble and he was greatly committed to his duty, it can be told that he handled the situation immaturity, because

① he knew that the ~~the~~ person he was going to inspect has good political connections. So even if he catches ~~the~~ him, the person may be set free in future which will defeat the purpose
