- ① "Self-realisation" is knowing the inner self i.e. one's own virtues, vices, weakness and strength.
 - ② One ~~can~~ with self-realisation helps one to understand his weak points, so that he can work in right direction to rectify them.
 - ③ e.g. - in mythology self-realisation of robber Ratnakar helped him to turn into saint Valmiki.
 - ④ By self-realisation, one can learn from his ~~sad~~ experience and errors and take corrective measures in future.

- ① From this quote, "head" implies mind or knowledge; "heart" implies love and affection.

Remarks

- ② It means, to control one's own mind and body, one should use his own knowledge, and wisdom, because they act as controllers of mind ~~and~~.
- Q.
- ③ Similarly to control others, use of force may bring short term success, but use of heart i.e., love, affection, non-violence brings long term and sustainable results.
- ④ e.g.- In India's freedom-struggle, use of force by British helped succeeded them in conquering India for some years. But finally, Gandhi's love, non-violence earned him long term success.

- ① Buddhist ethics preaches the end of desire as desire is the main reason of sorrow and suffering.
- ② So one can get control of his wish and desire by leading a simple,uster life which is in the direction of moderation.
- ③ Similarly Aristotelian ethics preaches the life where no person moderation, i.e., moderate life will not cause harm to anyone.
- ④ So both Aristotelian and Buddhist ethics are alike formally.

 Discuss with respect to the usage of religion as a tool by the people to increase enmity.
 (150 Words) (10 Marks)

- ① Parochialism means biasness and blind support to a particular group.
- ② It leads to various ill effects in the society especially in the term of a devilish leader, who exerts influence over others and drags them in wrong direction.
- ③ e.g.- Because a leader exerts maximum influence in his group and a parochial leader creates a division in the society by creating enmity between various groups.
- ④ Now-a-days religion has been used as a tool to create such division and enmity in the society.
- ⑤ e.g.- Nazi leader Hitler successfully used religion to create enmity between

the Jews and Nordic Aryans which led to mass killing of Jews in Holocaust.

⑥ Effect of such parochial leaders is a main reason of increasing evils like communalism, regionalism, ~~racism~~ proliferation of radical extremist organisations like LSIs.

Transparency means openness ~~and~~ of every step and work done by the government or an individual.

② Similarly accountability is the answerability or ability to justify a decision taken.

③ Transparency helps to keep the citizen aware of every decisions taken by government.

④ Once citizens become aware of decisions and works of government, automatically government will be accountable to citizens

⑤ Because a well informed citizen can ensure accountability in the form of voting rights given to him.

- b) ① Transparency is an ethical imperative for a government, because it helps to keep a check on arbitracy and unilateral decision taken by government.
- ② Because, if every decision will be taken with proper assessment and approval, so that it can meet its main objective i.e. public welfare.
- ③ e.g. - in the flagship programme MGNREGA transparency and accountability is ensured by the provision of social audit, and result is it has been able to alleviate poverty upto much extent.

- ① "common good" implies that welfare and benefit of the society as a whole.
- ② It looks everyone ~~starting from~~ starting from good to a evil person under the same lens.
- ③ Voluntary organisations like NGOs, civil society groups can play an important role in achieving this common good.
- ④ They ensure that government decisions and welfare programmes are not biased in support of a particular group or section of a society.
- ⑤ So it helps to bring the vulnerable and backwards to the same development level as that of others.

⑥ e.g.- success of government programmes like Forest Rights Act (FRA), Drought Prevention Act can be greatly attributed to the efforts of such voluntary organisations.

③ Beliefs implies an external sense of ~~e.g. for~~ preference to someone mostly a living object.

④ e.g.- Lenin had strong belief in the philosophy of Karl Marx.

⑥ ① Honesty implies strong sense of dedication to one's duty without looking for own advantage.

② It is an important virtue needed in a civil servant. Not required

③ Loyalty is a sense of attachment to a particular group or person.

④ e.g.- a dog is loyal to his master.

Q7. What is normative ethics? How does it save a leader from deviation from the ideal path? What difficulties occur if a Civil Servant rigidly sticks to normative ethics rather than taking help from the wisdom of normative ethics by factoring in the ground realities?

(150 Words) (10 Marks)

- ① "Normative ethics" implies rule based ethics i.e. the principle of ethics where rules are specified and a person has to work as per it.
- ② Strict adherence to rules helps one to set his objectives and the ^{destination} path where he can reach by adhering to such rules.
- ③ So it will help one to a leader not to deviate from its ideal path and achieve his objective.
- ④ But such strict adherence to normative ethics without taking help of wisdom of normative ethics can cause following issues -
- ⑤ The civil servant may be strictly rule dependent which may sometimes be against public welfare.

- (b) He will not be able to solve the issues if he faces an ethical dilemma where principles of normative ethics may not work.
- (c) It will also lead to ~~decreed~~ reduced innovation and discretion which are sometimes needed for good and efficient governance.

Q8. What is structural discrimination? Why is legislation alone insufficient to alleviate them? Suggest ethical measures to remove the structural discrimination.

(150 Words) (10 Marks)

- ① Structural discrimination, is the type of discrimination which has been embedded at the very foundation or structure of our society so that the system gets transferred from generation to generation.
- ② e.g.- discrimination based on caste, religion etc. can be termed as structural discrimination in Indian context.
- ③ Although various legislations are there to alleviate them, these are still prevailing in our society. e.g.- Prevention of ST, SC Atrocities Act prevents discrimination of STs and SC on various grounds.
- ④ Because, legislations alone are not enough to remove a social evil. Also it is very difficult to change a societal mindset of which is suffering from lack of knowledge, education, backwardness as in India.

Remarks

- ⑤ Following ethical measures can be taken in this regard-
- ⑥ Sensitisation of the society by awareness creation.
- ⑦ Involving various NGOs, civil society groups to teach the mass against such discrimination.
- ⑧ Increasing level of education and literacy among people.

- (a) What is conscience? Explain the following quote with respect to that - "In matters of conscience, the law of the majority has no place". (Mahatma Gandhi)
- (b) How is conscience shaped by the education, law, and authority? What is the importance of conscience in decision-making? (75 Words Each) ($5 \times 2 = 10$ Marks)

(a)

① Conscience is the inner-sense or inner thought which shows the right direction in the times of dilemma and confusion, so that one can take right course of action.

② As Gandhiji said - "In matters of conscience, the law of majority has no place." It means conscience is an internal mechanism to guide one's path.

③ The statement says that conscience helps one to choose the inherently right path by doing right evaluation of various factors. So majority views may be detected in matters of conscience.

(b)

① Education, law and authority etc. helps one to broaden his/her mind by

getting knowledge, experience and wisdom.

- ② Thus it creates a robust and ethical internal mechanism which is transformed in the form of conscience.
- ③ Conscience greatly helps in decision making especially in case of ethical dilemmas which are frequently faced by a civil servant.
- ④ In such cases there are multiple seeming equally right choices. In such cases one's inner conscience shows him the right path to take a sound decision.

Q10. "A person may cause evil to others not only by his actions but by his inaction, and in either case he is justly accountable to them for the injury." Elaborate the essence of Mill's statement with respect to corruption. (150 Words) (10 Marks)

- ① "Corruption" has turned into a society evil in today's time.
- ② In this context, the above statement implies that both action and inaction in the part of a civil servant can cause injury to the system and he is justly accountable ~~to~~ for them.
- ③ E.g.- a civil servant by his actions like corruption and demanding bribe causes harm to the society by diversion of public money and affecting public welfare.
- ④ Similarly suppose a civil servant is indulged in corruption. If a his senior authority is well aware of it and doesn't take any actions, gradually this corruption will engulf the whole system.

Remarks

⑤ Thus the inaction on the part of the senior official affected the public welfare and system as a whole.

⑥ So he is also accountable for his inaction from his party whose duty was to take action against the corrupt official.

Q14. You are DM of a district where a big infrastructure project is underway which is apprehended to displace large number of villagers. The work of building that infrastructure is often interrupted by environmental and social activists who off and on organize massive protests. The project is stipulated to be commissioned very soon by the Prime Minister and the project work has stopped for more than two weeks. Which of the following options would you prefer to take and why?

- (a) Use of the force to disperse the protesters and arrest the leader.
- (b) Talk with the leader, hear the complaints and apprehensions, convey that to the government and request quick redress or assurance in writing for the same so that work can begin.
- (c) Try to negotiate, give assurance of redress of complaints and apprehension as far as possible and request the leader and protestors to leave the project site immediately, failing which, resort to the use of force immediately.

(250 Words) (20 Marks)

a) If I use force to disperse the protesters and arrest the leaders

Benefits -

- ① The infrastructure may run smoothly without any opposition or protest.
- ② It will also be in accordance with law as the project has been sanctioned by the highest executive that is Prime Minister. As a civil servant my duty is to work as per the wish of policy executive.

Remarks

Issues -

- ① Situation may worsen further with more protests
- ② Trust deficit with the administration
- ③ It may lead to large scale displacement of villagers
- ④ If 3rd option is adopted -

Benefit -

- ① It will act as mediator between government and the local people by talking to the leader
- ② Protest may not occur if the leader agrees to the support of the government
- ③ Government may work towards the redressal of the issues raised by activists

It may further escalate the situation.

Issues -

- ① Delay in project initiation
- ② The leader might not agree and protest will increase
- ③ If 3rd option is adopted -

- ① Negotiation with the complainants will give them a chance to keep their stand so that

② It will also help to sideline the occurrence of protest

③ As a govt. official it is my duty to give warning before extreme steps are taken.

Issues -

① The protestants may not agree by the negotiation

② Threatening to use force may cause more resent among the people

In this situation I will adopt the 3rd option and try to negotiate with the local people and make them understand the benefits they will get because of the project. If they still threaten to sit on protest, then after giving warning force may be applied.

Q15. Strict discipline is the hallmark of a good administrative system. There are increasing cases of subjugation and insubordination in administrative setups which de-motivates both subordinates when they are suppressed and bosses when they are disobeyed. Annual Performance Reports and strict adherence to the official Code of Conduct are the two most important mechanisms to ensure discipline in an administrative system. Suppose you are head of a government department with 50 subordinates, elaborate how would you act in the following situations?

- (a) How often would you use Annual Performance Report as a threat to the erring officers and why?
- (b) Is Annual Performance Report a full proof system of assessment of employees?
- (c) Do you think that two way assessments (boss & staff and staff & boss) can lead to a full proof assessment of the staff in an administrative system?
- (d) Can you argue that motivating the staff for adherence to Code of Conduct rather than threatening, censoring or firing is more sustainable way for maintaining discipline in a large organization and the latter as means to restore discipline are dispensable?

② As the head of a government department my work is to work with the subordinates unitedly with mutual co-operation so that a healthy work culture is maintained.

① Threatening the subordinate by

Annual Performance Report (APR) is not the right course of action.

③ It will erode the healthy work culture.

④ So at 1st instant I will try to guide the subordinate in right direction if he does some error.

⑤ In spite of frequent warning also if he

Remarks

② neglects my advice, then APR may be used to keep bring him to right direction,

⑥ ① APR is not necessarily a fool proof system of assessment of employees, because it is mostly prepared by the next senior authority of the employee.

③ He may misuse his discretion in preparing APR.

④ The line of thought of both the subordinate and boss may be different and this will affect the APR if the subordinate is right.

⑤ It is biased.

c) ① As a solution 3-way assessments ~~can~~ can be done for better administration.

② But it will also cause various issues like erosion of authority of the boss.

③ This will affect his performance as he can't take independent decision.

- ④ Guidance and discretion of senior authority in many cases is necessary for good governance which will not be possible by 2-way assessment system.
- ⑤ Motivating the staff for adherence to code of conduct will remove the fear from the mind of employee and he can work more efficiently.
- ⑥ Threatening or forcing them work may cause more fear as good work culture can't be maintained.
- ⑦ Because of continuous threat or fear subordinates may be to take any innovative, independent decision for public welfare. It will affect the governance structure and output finally.

Q16. You are head of an organization which has large public interface. One day an old man approaches you and complaints that one Assistant incharge of Old Age Pension Scheme is demanding Rs. 100.00 from him for clearing his pension claims. He has further revealed that this is a common practice in this office and those who do not pay the bribe money, are harassed. You have become very upset with the state of affairs and want to solve the problem of the old man alongwith bringing some qualitative change in the work culture of the organization, for better service delivery.

- (a) What are the options available to you?
- (b) Evaluate each of these options and choose the option which would you adopt, giving reasons.

(250 Words) (20 Marks)

As the head of the organization, my duty is to ensure public welfare and transparent, corruption free governance. In this case the complaint of the old man shows the prevailing corruption in the system which needs to be wiped out.

① Following are the options available to me in this case

- ① Showing indifference to the complaint of the old man and do nothing
- ② Directly suspending the concerned officer against whom complain has been made
- ③ Properly investigate the reality of the complaint and if found correct then take preventive steps.

Remarks

(b)

1st option -

It is totally against the ethics and morality of the administrator. Also it will give more wing to the evil system prevailing in the organisation and ultimately public will suffer.

2nd option -Benefits -

- ① Quick decision making and the old man will also get his pension quickly which will ensure public welfare.
- ② It will set a right example and other employees may tend to indulge in corruption in future.

Issues -

- ③ Decision may be biased, as the reality of the allegation is still not known.
- ④ If the concerned officer is innocent, it might result in loss of morale of the officer.

Remarks

3rd option -Benefits -

① Doing investigation will help me to know the reality of the allegation, so that right decision may be taken.

② The concerned officer will also get a chance to keep his stand which is in accordance with Principle of Natural Justice.

Issues -

① It will be time taking

② Investigating team may be biased and support the officer

Q17. There are spiritual gurus and social activists who enjoy big following among people. Their messages flow easily among masses & people follow them. However, government spends lots of money on advertisement of its welfare and development programmes, yet people's response and participation is sluggish as exemplified in the "Swachch Bharat", "Beti Bachao, Beti Padhao", "Afforestation" and "Family Planning" schemes among others. There are many social ills such as child labour, dowry, and aggressive sexual assault of women. Answer the following questions based on the above case:

- Do you believe that involving spiritual gurus and social activists to increase peoples' participation in welfare programmes is good? Give reasons.
- What are the difficulties in involving spiritual gurus and social activists for promotion of the government's welfare programmes? (250 Words) (20 Marks)

People now-a-days are easily influenced by the spiritual gurus and social activists because of their influencing characters, but they don't show good response to government welfare programmes.

① In this scenario involving spiritual gurus and social activists may be helpful and may give quick results.

② But it is ~~not~~ may not be right to involve them in ~~the~~ promotion of welfare programmes.

③ Because, there is no guarantee of integrity of such persons, as seen in many cases now-a-days.

(4) Promotion of ~~welfare~~ welfare programmes by an ~~unethical person~~ will not be the right course of action.

(5) So before involving any such person in promotion of programmes first the ~~track record of his life~~ should be properly examined.

If found satisfactory, then they may be involved in the promotion programmes.

Previously also many celebrities, actors, sports-persons have been employed for such advertisements and it has achieved some success.

In the era of increased digitalisation and use of mobile phones, internet, instances of pornography sex related crimes have increased many fold. As the secretary in Home Ministry my job is to take steps to stop such menace.

- ② Laws against sexual crimes should be strengthened in support of which I will
