REMARKS

Q1. The remains of Buddhist architecture and sculpture at Sanchi in Madhya Pradesh tells the story of the rise, flowering and gradual decline of Buddhism in India. Comment.

(10 Marks)

Remains of Buddhist architecture & sculpture have been found at Sanchi in Madhya Pradesh. The most prominent among them is the Sanchi Stupa that was built over a period of time.

The Stupa was primarily a wooden architecture which was later beautified and enclosed by walls. Also there was growth of other Buddhist sculptural forms.

But gradually during the late ancient period this started to decline. The main reasons for this decline were as follows:

Buddhism was started as a reaction against the ills of Hinduism but gradually it inculcated some of those ills in itself e.g. the monks used to live extravagant life.

Hinduism tried to accommodate Buddhism by calling Buddha, one of the incarnation of Vishnu.

Alarmed by the phenomenal rise of Buddhism, Hindus reformed their religion, like practice of non-violence in Hinduism is said to be borrowed from Buddhism & Jainism.

Subhas Chandra Bose was one of the most prominent leaders of Indian national movement and member of Congress. He was elected two times the President of Congress, second time virtually defeating Gandhi which speaks a lot about his popularity.

Subhas Chandra Bose was most vocal in giving the socialist turn to Indian National movement and it was during his Presidency that National planning committee under the chairmanship of J.L Nehru was set up.

When he was expelled from congress by disciplinary action, he set up Forward Bloc to mobilise masses to fight against the British.

During the Second World War he led the Indian National Army (INA) soldiers to fight for the freedom of India.

From the above it is clear that contribution of Subhas Bose in Indian freedom struggle is no less than any other leader. He set an example for the masses to follow. He was

always ready to lay down his life for the country. And at the same time he was an staunch supporter of cause of farmers marginalised. Infact the RWA struggle & peasant revolt in the Indian Army is said to be one of the reasons for Indian freedom.

Ideological foundations of Modern Indian Nationalism

Socialism:-

Socialism:- Socialism is one of the prominent ideologies in the modern Indian nationalism. In the Indian Nationalism in this ideology became dominant during 1920s & 30s post Bolshevik revolution. This ideology was responsible for India becoming a socialist state.

Non-violence - Gandhi, In the modern times put the foundations of this ideology in India. Though this was not a new ideology (as it was an inherent tenet of Jainism) but Gandhi used it in the freedom struggle.

Emphasis of Inclusive development

Factors that led Indians to introspect

During the time when Britishers came to India, India was a stagnant, static, quiescent & backward country. This helped the modern Imperialist state to politically subjugate the country. When the country was politically

subjugated, people especially from educated Intellectuals like Raja Ram Mohan Roy, Deendayal were forced to think about the reasons for this state of the country. The prominent reason being the second class citizenship granted by Britishers to Indians. Issues like racial superiority, drain of wealth, cultural imperialism were the main factors behind this.

Non Co-operation Movement was carried out under the leadership of Gandhiji from 1919 to 1922. Gandhiji had promised that if people undertook the non-cooperation pledge then Swaraj will be attained in one year.

Though the movement could not attain Swaraj in one year but it did give a new direction and energy to the national movement.

The Hindu-Muslim unity was attained as Gandhiji merged the non-cooperation movement with anti-Caliphate struggle of Muslims.

Co-operation of women was prominent as large number of women came out of seclusion and participated in picketing and other activities.

The movement made the Indian freedom struggle truly mass struggle as large scale mass participation was seen in this movement.

The movement energised the whole nation & increased the awareness of people against

- Q8. Apart from persuasion and diplomacy, use of force was an effective strategic move in integration of princely states. Do you agree? Substantiate. (10 Marks)

After the lapse of British paramountcy on the Princely States, they were given the option of either joining to India or to Pakistan. But some of the princely states like Kashmir & Hyderabad still dreamt of creating an independent state.

National leadership primarily adopted a persuasive & diplomatic approach to achieve national integration: e.g. emotional appeal to the rulers of Princely states to listen to the demand of people, granting of concession like pension & pay raise to rulers etc.

But those Princely states who were not ready to listen, use of force became inevitable. Hyderabad State was not listening to the Indian leadership. It even threatened India to join Pakistan. Then alarmed by the plight of people in Hyderabad (due to Razakars) Indian Army took 'Police Action' in Hyderabad and it was made part of India.

Diplomacy.

- The ruler of Jungarikh was instigated by Pakistan & was not listening to the demand of their own people as well as Indian leadership. There also Indian government took action. Mahasat Khan flew away to Pakistan.

Thus it can be said that Integration of India was achieved through diplomacy, persuasion & use of force.

- Q9. Though India won the war of 1971, yet Shimla Agreement is seen as a diplomatic defeat of India. Critically Analyse. (10 Marks)

Shimla agreement was signed between India & Pakistan after the surrender of Pakistan army in East Pakistan and defeat of Pakistani army on western borders. The main points of agreement were as follows -

India agreed to return all prisoners of war to Pakistan.

Status quo was to be maintained on the line of control. Cease fire line became LOC.

All the disputes between the two countries including to be solved through bilateral negotiations.

Taking the frequent ceasefire violations and an attempt to internationalise the Kashmir issue it is said that though India won 1971 war but diplomatically it was defeated. The

main reasons being it maintained the status quo on the LoC even though Indian army had significant gains in Pakistan. Also it did not stop cross border infiltration into the Indian

territory & there was. Kaikh conflict in 1899.

Feu Holocaust towards the state of Palestine was started gradually after the first world war when Palestine became the mandate of Britain. Feuls gave the explanation that Palestine was the actual homeland of Feuls & they were forced out of their homeland after the advent of Islam in 6th century AD. But the actual reasons appears to be the strategic significance of the area (As the area is located near Mediterranean sea - an important sea route).

With the support of Britain few of the Feuls migrated to Palestine but one Hitler

~~Although Europe has seen two massive devastating world wars but even today it is one of the most productive & economically well-off region. The reasons are as follows-~~

Industrial Revolution - Industrial Revolution took place in Europe in 1750s and they made the continent the goods supplier of the world. Due to Industrial revolution Europeans generated huge wealth from worldwide.

Colonisation & exploitation - After the Industrial revolution (though even before that) European powers like Britain, France, Spain, Germany etc. colonised the whole world. They exploited their resources & drained huge amount of wealth from the colonial economies. e.g. Drain of Wealth from India was around 1/3 of the GDP during those times.

Renaissance & Progressive attitude of people - The Renaissance took place in European countries & Europe

emerged from dark age. This gave a rational outlook to people. This is largely responsible for technological advancement of European countries in present times.

- Added to this favourable climate and productive soil has helped Europe to remain one of the most productive regions.

Indian society's strength lies in its ancient roots: Huge tolerance, respect for women, and openly accepting many ideas were the major reasons why Indian society was able to sustain itself. e.g. When non-violence became an accepted credo in the Indian society, Hindusim immediately accepted it.

Our society assimilated many of the cultures that came to India. e.g. Persians, Indo-Greeks & other central Asian invaders in ancient times were assimilated in the Indian society. At the same time in the medieval times Turks & Mughals etc. were assimilated in the society without any large scale conflict.

~~At the same time 'Bharat' is a term used to describe those sections of the society who are poor, marginalised & even neglected by the government & society.~~

~~India & Bharat are more in conflict rather than symphony. The reason being the huge divide of haves & have-nots that has generated in the society. As per a recent report the gini coefficient (a measure of inequality) in rising post-1991 reform period. In the cut-throat sections farmers are committing suicide while other areas more are being spent on luxury. This has generated a huge discontent in the~~

Society: The corruption & exploitation has further worsened the situation. The tribals have been far long exploited by outsiders. The minerals found on their land have been used to develop other regions. Also the pollution which is mostly contributed by better-off sections impacts poor the most.

Media is sometimes referred to as fourth pillar of Indian democracy. Its impact on Indian society are as follows:-

- As an Information provider It helps in making informed citizenry. Citizens, when they are informed are likely to make better decision & thus it improves the decision making power in the society.

- As an opinion maker It helps in making opinion against the wrong policies of the government, exploitation of poor & also wrongdoing of government agencies. e.g. Unearthing of 2G scam, Information on Afspa & Farmers suicides etc. Due to media impact government is sometimes forced to take action against culprits.

- It acts as a major medium of transfer of culture. In this way it has played a major role in integration of the country.

But at the same time media has been accused of biased reporting, paid news & promoting

In this context, are Indian coasts geared up to take up the challenge? Critically discuss? (10 Marks)

Global warming is facilitating sea level rise through expansion of water as well as melting of glaciers.

In this scenario the rate of sea-level rise has increased to 1.2 inches per decade which is an alarming number.

Taking the Indian situation into consideration, Indian coasts are quite vulnerable to any sea-level rise due to huge population pressure in coastal areas. But India doesn't seem to be taking any specific step to address this challenge. In fact as per the Saldanha Dayak Committee recommendation Government has further liberalized the norms for developing the coastal areas.

The city of Mumbai which is most vulnerable to any sea level rise there is a need to develop alternate areas for settlement.

Q19. What are the causes of the Cauvery River water dispute between Karnataka and Tamilnadu? Why is there no amicable solution yet? Examine. (10 Marks)

Cauvery River water dispute is a dispute for sharing of water of Cauvery between Karnataka & Tamil Nadu. The major causes are as follows-

- Inability of both the parties to reach at an amicable solution even after setting up of Cauvery Water Tribunal under article 262(2) of the constitution.
- Reduced water quantity in Cauvery river due to overexploitation & climate change
- Politicisation of the issue for political gains & emotional response from people. e.g. Burning of many public properties in the city of Bengaluru.

There is no amicable solution yet over the dispute because -

- Due to politicisation of the issue the political leadership can't hold back now. Any such activity will result in political backlash.
e.g. passing of orders by Karnataka LA against

- No proper response from the central government which should have been taken to the issue with both the parties.
- Improper functioning of River Water Board.

Q20. Recent scientific studies show that climate change may intensify the effects of Jet-stream. What can be the implications of this? (10 Marks)

Jet-streams are upper atmosphere circulations. They are found to be flowing below the tropopause before & after the monsoon in the Indian subcontinent. (around 25°N latitude)

These tropical westerly Jet-streams are found to be co-related with Indian monsoon. The reason being - Indian monsoon becomes active only when these jet-streams become inactive from the Indian subcontinent. Seen in this context any intensification

of these westerly jet streams will adversely affect the monsoon pattern in India. This will lead to problem of drinking water, food security etc.

But at the same time after the withdrawal of these westerly jet-streams an easterly jet stream originates in the Indian subcontinent (around 15°N latitude). This easterly jet stream has been found to be positively co-related

with Indian monsoon. And hence its intensification will lead to positive outcome.

Q21. Reducing regional disparities has been one of the significant goals of Indian democracy. Can the smart cities mission help India achieve this objective? Critically analyse.

Huge amount of disparity is visible in India.
 There are islands of prosperity floating over vast land of poverty & hunger.

India post-Independence adopted a sustainable pattern of economy & hence reducing disparity became one of its aim.

Smart cities mission has been launched in this context to holistically develop a city. The idea is to make the city more livable & sustainable as well as ensure rights of every person in the city. The project adopts an area approach to development & then adopting a whole city approach. Special emphasis is being laid on development of slum & neglected areas. An expenditure of 4.800 Crore has been assigned for next 100 years for 100 cities.

Putting above figures into consideration surely the mission will help in making

cities more livable but the flipside is that there is a need to correspondingly revive the rural economy because unless we stop huge migration (due to push factors) we can't hope to achieve the dream of sustainable city. Also the development of rural areas is equally important.

Taking the current state of Inter-state river water boards into consideration (which are constitutional bodies u/A 262) it is quite likely that they will become just another institution.

The problem of water in India is multi-pronged like there is pollution problem, ground water problem & scarcity issue.

Water is a state subject so a national water commission is less likely to be effective.
