The current situation of US President Donald Trump is an example in point. He is known to be ~~greedy~~ and lives a materially ~~rich~~ life. This seems to have alienated him from some of his followers. Thus it becomes crucial to be humble at the top in all spheres of life.

### Professional humility

Leaders like Warren Buffet ~~and~~ have proven the importance of being humble time and again. He travels by economy class flights, wears the most basic clothes and has chosen to donate most of his wealth to charity. This humility doesn't take away from his professional excellence.

The recent case of Infosys India is also important. The founder Narayana Murthy emphasised on retaining core values of humility that are a part of the company's ethos in light of the increase in compensation of the CEO and COO. 4. There are not enough jails, not enough police; not enough courts to enforce a law not supported by the people.

'Law is order and good law is good order'

This line by Aristotle aims to highlight the distinction between a good and bad law. As mentioned in the title of the essay, this difference can arise from whether it is supported by the people or not. Law here means any policy or rules created by executive order and those passed by the parliament as legislative bills.

In this essay we aim to understand the importance of people's support for a law to succeed. We analyse the purpose of laws and their evolution. We study the reasoning a law may not be supported and then conclude with the idea of a well accepted law and its constituents. We also discuss examples of laws not liked by people i.e. the citizens, to improve our understanding of the issue.

## The purpose of laws

In our modern democratic setup laws are formed by those accountable to the electorate i.e. the citizens of the country. This indirectly, if all goes well, laws aim to protect the citizens of the country and are a chance to codify the concerns of the citizens. For example the National Food Security Act 2013 aims to provide food rations to the hungry masses. It assuages the concerns of 67% of the population too.

laws are also formed to implement and uphold the ideals of our constitution. As our country derives power from the constitution it becomes important that ~~etc~~ laws are made to protect it. As a result we have laws that protect fundamental rights of our people, like the ~~Provention~~ Civil Liberties Act 1955. We also have laws that implement the vision of India as ~~desearst~~ mentioned in the directive principles of state policy. like Prevention of cruelty against animals Act 1960 etc.

These reasons for the existence of laws are truly noble and will usher in the 'Rule of law' as discussed by John Adams. However laws are also used by the establishment of the day to maintain status quo and propagate itself, at times at the cost of citizens. This leads to laws lacking ~~mass support of masses~~ for example, slavery was legal in USA till 19<sup>th</sup> century even though it violated the rights of many. It was a means to ensure stability in power equations. This leads to loss of support by masses.

### Reasons why some laws lack support

As mentioned above, ~~at~~ at times there are right reasons to do not support a law as mentioned in these lines by Martin Luther King Junior -

'It is our moral duty to oppose immoral laws.'

This was the reason behind civil disobedience movement led by Mahatma Gandhi during India's struggle for independence. Gandhi ji opposed unjust laws throughout his life and the existing justice system of the time including the threat of arrest by police or even the threat of being held guilty for violation by the court didn't stop him. He called himself lucky to be violating an unjust law of sedition.

Similarly certain laws that are immoral because they violate the constitution also can not be suspended. The yet to be passed Citizenship Bill 2016 is an example of this. This bill discriminates between people on the basis of their religion and thus is violative of their fundamental rights. Thus there are certain laws which lack support for the eight reasons. There are other reasons too.

— Since Article 14 of the Constitution guarantees equality to all persons, citizens and foreigners, differentiating between people

Remarks on the grounds of religion would be in violation of Constitution.

— Some has been remarked in Rajya Sabha in Aug, 2013 in the matter related to Refugees

Economic reasons are the most imperative here. Individuals violate laws for economic gains. For example child labor is prevalent despite being sustained due to <sup>good</sup> economic cost benefit analysis of employing a child v/s an adult. Same is the case with other banned activities like organ donation.

Social reasons are crucial in a country like India. Laws which are pernicious in nature or different from existing social realities and structure often face lack of support. These include violation of the manual scavenging prohibiting Act or ~~child~~ <sup>child</sup> prevalence of witch hunting, cruel marriage etc. An active judiciary and police can address this lack of popularity by swift action against perpetrators.

In such a scenario, the role of our judicial-police complex changes ~~becomes~~

role of courts, police and prisons

our justice system is rehabilitative in nature aiming to reform individuals and reduce recidivism. Their aim is to ensure rule of law exists.

When laws are supported by masses, the role of our justice system is limited to ensuring justice is done swiftly and those who are violators of the word of law are punished so that others are disincentivised from breaking the law too. Here masses too support the implementation of law and have faith in the system to lead to the right outcome.

However, when for the reasons listed above the citizens do not support the laws of the day the justice system becomes a means of exploitation and works against the will of the people. For example during British Indian rule in India persons were filled with ~~black~~ lakers of protesters. And yet this did not weaker the system, in fact emboldened it.

In such a scenario implementation becomes weak as citizens do not aid the police or courts in implementation activities like recognising perpetrators of crime, giving evidence etc. At times they advisely break laws and escape conviction by crafty means.

Another outcome of lack of support for laws is that citizens lose faith in the justice system to do the right thing and take that power themselves. The recent <sup>relevant point of view</sup> increase in lynching accidents is due to the belief of a small minority in the ability of courts to do justice. and thus they believe in parallel justice.

Thus the jails, police and even the courts loose their poises when laws are not popular. To prevent this we must ensure 'good' laws are made.

### Good Laws and Conclusion

Immanuel Kant said good laws are the ones that are universal in applicability. In addition to this we must ensure the laws and policies that are being formulated are in line with the spirit of the Constitution and not merely its wised as seen in the recent order of prohibiting cattle trade. It is also important to include the people via consultation when formulating laws so that they are in sync with existing realities. The recent method of taking ~~off~~ suggestions on draft bills online is a start towards this. Lastly, implementation of laws should also be citizen centric and citizen friendly so that our jails, courts and police can justify their mandate as, 'The will of the people is the best law.'
