





- Bodily autonomy of woman.


The ethical justification depends on the schools of thought -

Q17. In a municipal town, there are some primary schools and dispensaries, where children of poor people, especially living in slums receive their primary education and basic health care. The schools have good buildings, infrastructure and teacher. However, quality of primary education is far from satisfactory. Similarly, dispensary having reasonable good facilities hardly comes up to the expectations of the people. Whenever the poor people approach the health officials (doctors), they are rebuked at. A young and promising Municipal Commissioner of corporation wants to improve the situation.

Based on the situation stated above, answer the following questions

- How would he improve the working of the dispensary and ensure that doctors and paramedical staff are made accountable?
  - What steps he should take so that quality of primary education improves? What are the limitations before Municipal Commissioner?
  - How to strengthen moral responsibility among teachers and health officials? What could be its effect on the overall performance of the dispensary and school?
- (250 Words) (20 Marks)

The case relates to poor quality of primary education and health care, even after infrastructure is good.



(a) Some steps to improve working of dispensary

- Talk to the doctors and paramedical staff and understand what their problems. Try to address them.
- Use emotional intelligence to persuade the doctors to view this as a service to the nation.
- ~~Set~~ Set up a grievance redressal mechanism for the people.

(b) I would follow ~~set~~ similar steps to improve the quality of primary education, such as persuading teachers, conducting social audits, install CCTV cameras, etc.





(1) Instead of waiting for a response from seniors and delay decision-making, he should continue to implement the schemes in a fair, transparent and objective manner.

(2) If any politician makes demands that are unethical, he should politely refuse. His only allegiance is to the Constitution of India and the Rule of Law.

Her in-laws want a boy child to act as inheritor of the family and they have also ordered to abort the child if it is girl. Later her in-laws insisted hard and connected you with the Health Minister on mobile phone. The minister said the doctor to help them in all possible manners without saying anything about the issue at hand. Thus reporting about the issue to police is waste.

Based on the above situation, answer the following questions:

- (a) What are the ethical dilemmas in the above case?
- (b) Do you think that your moral obligation also demands to help your friend?
- (c) A doctor in a public or government hospital should obey the Health Minister for whatever he says. Do you agree and why?
- (d) What steps will you take in the above situation? (250 Words) (20 Marks)

The case involves ~~an~~ a woman who wants to determine the sex of the foetus and abort it if it is a female.

(a) Ethical dilemmas

- (1) Personal ethical responsibility of helping my friend
- (2) Upholding the rule of law, as sex determination is clearly illegal under PCPNDT Act, 1994.
- (3) Ensuring the right to life of the foetus if it is a girl.
- (4) Issues around ~~for~~ women empowerment, patriarchal mindsets and lack of female autonomy over her own body (and foetus)

(c) ~~No~~ A doctor should ~~agree to~~ obey the Health Minister only if his demands or orders are permissible within the framework of law.

A doctor ~~does~~ owes allegiance only to the patient, Constitution of India and rule of Law.

(d) Steps I will take

- (1) First, I will tell my friend that I will not conduct sex determination as it is illegal under PCPNDT Act.
- (2) I will counsel her and her husband about the virtues of having a girl child

I hope my persuasion will convince the husband to explain his family members not to demand a sex determination.
