- v) Overcoming our weaknesses, attitude helps us improve. This is because attitudes can be corrected through constant endeavours.

In these ways attitude has multiple functions in shaping the character of individuals.

Crowdfunding refers to the process of seeking ~~public~~ funds ~~from~~ by using a social media or other platform from the people.

It is generally done for projects which have immediate returns for people or where people have direct interests. eg, in a ~~new~~ social startup, to build waste treatment plants, to make a movie on a social issue etc.

It's success will be due to following factors:

- i) People have direct participation thereby they will hold the accountability of project.
- ii) Only those projects with a foreseeable future will be funded by people.
- iii) Entrepreneurs have to remain transparent in their dealings, thereby checking any

The crowd funding has numerous positive effects like,

- ii) Young, innovative and 'need of the hour' ideas will get recognition. This will improve the spirit of inquiry and reforms.
- iii) Unethical elements and practices like corruption can be minimised.
- iv) It will strengthen democracy as people's participation in nation building will increase.

Hence, we must develop effective regulation for crowd funding to reap its many benefits.

Q4. What are the signs of low Emotional Intelligence? Where would you place yourself with respect to these signs? What would you do to improve your emotional intelligence level?

Emotional intelligence refers to the ability to make emotionally and rationally sound decisions.

It has five components and the weaknesses in these components leads to low emotional intelligence.

The signs ^{in these components} ~~and~~ are:

- i) Self awareness: If we don't have self awareness, no personal value statement, we will have low emotional intelligence.
- ii) Self regulation: Inability to control our urges, which may lead to greed, hate, anger, lust and other problems, leading to low emotional intelligence.
- iii) Internal motivation: Without this, we will not remain stable in failures, lowering our emotional intelligence.
- iv) Social awareness or Empathy: Our inability

to have empathy would not lead to selfish and greedy attitude...

v) Social skills or Persuasion: Without this, we will remain ineffective in regulating our colleagues', friends and others' emotions.

I ~~can~~ have made a conscious attempt to develop ~~can~~ emotional intelligence by having a personal value statement and try to follow it. However, sometimes I feel to lose internal motivation. On empathy and Persuasion too I continuously try to improve. ~~persuasion~~

These can be improved by:

- i) Having a conversation with my parents, friends to make me feel motivated.
- ii) To visualise myself as a more emotionally intelligent person leading to attitudinal development.
- iii) Seeking feedback from my peers on where to improve.
- iv) Trying to understand other's perspective before setting out to persuade them.

b) ~~Confusion~~ To any decision making involving complex choices, there is confusion and dilemma at the first

stage, but a leader must resolve them through reason and emotions to arrive at an objective, balanced and impartial decision.

SECTION - B

Q16. Due to fall in agricultural productivity and faulty procurement policy, a marginal family head has committed suicide and left his family and two children, daughter (12 years) and son (8 years). They shifted to nearby city in search of work and ended up living in a slum. Both children had to leave their studies and mother went searching for some household work. Finally she is a maid at your home. She works at your personal residence. One day she felt ill and ask her daughter to continue in place of her. Your wife is an IAS officer and quite busy. She does not have time to take care of old in-laws who needs constant care. Though there is a nurse to take care of them but there is a need of help in small household works also. So she gave consent to daughter of maid to continue in place of her. As she fears that your family may engage someone else and she will loose livelihood opportunity. When you raised the concern, she replied that this is matter of few weeks only, and also saying no will bring them on street. As in such a metro city one cannot survive without work, everything has a cost. You are Mayor of the city.

- (a) What are the ethical dilemmas related to it?
- (b) Your wife is in support of her placement as domestic worker as it will help her in balancing household and work responsibilities. Do you find her justification right?
- (c) How will you persuade her to change her decision? (250 Words) (20 Marks)

The case study deals with practice of ethical conduct in private life.

a) The ethical dilemma are:

i) whether to continue the daughter of maid for domestic work or find a new maid. Here child rights are against the survival of ^{the} family.

ii) Does ~~or~~ our maid not have the right to a sick leave $\frac{1}{3}$ ~~do~~ how to find a replacement for help in domestic work.

- i) Identify the key resources in my department who have exceptionally high skill and give them the task of training others. For this they will be compensated.
- ii) Start training programmes by getting external trainers.

- iii) Conduct regular proficiency tests so that employees have the desire to learn. The outstanding employees can be provided salary-benefits.
- iv) Procurement of state-of-the-art systems to better utilise the skill of employees.

Q18. Due to the contemporary developments in the information technology and convergence, the accesses of adults and children to media including variety of entertainment have increased. The children have impressionable minds and the quality of entertainment would have a bearing on them even when they grow adults. One moderately rich family has two children who have given mobile phones to their children with internet connection so that they can complement their studies with huge amount of information and aids available on the internet. Father encourage children to 'grow with the technology of their times' and rather than 'forcing discipline' on them. However, there is also misuse of information technology. The students are engaging in many undesirable activities outside the school, especially their exposure to many computer games (Blue Whale Challenge, Dead Space 2, Mortal Kombat, Medal of Honour, Call of Duty Black OPS, New Vegas etc.), which are known to be fatal and addictive, impinging on their education and value systems.

Answer the following questions:

- What steps parents can take to stop such new and pervasive kind of menace due to the unrestricted use of the computers and mobile phones?
- What is the importance of "forced discipline" in this case?
- How can discipline be sustained for a long time without discontent of the subjects?

(250 Words) (20 Marks)

The case study deals with the impact of technology on our value systems

a) To address such threats parents

can go for multiple approaches:

- Restricting the time of use of such technologies for use by children so that they use it for the most essential tasks.
- Establishing parental controls on such gadgets whereby only few applications

iii) Counsel their children on the need to balance the use of technology with other aspects like sports.

iv) Ensuring that children don't take electronic gadgets to schools.

v) Consulting with other parents and teachers to create the necessary ecosystem to check the menace.

b) Forced discipline is essential for small children because they have impressionable minds. They ~~can~~ can't decide their right and wrong.

Hence, in such a situation, forced discipline helps in ensuring that children follow the ethically and morally right conduct until they realise

By forcing the children to regulate their use of technology, they will be acting as 'unkind to be kind'.

C) Discipline in the long term must be driven from within and not imposed on subjects.

When subjects are aware about the reason of their action, its consequences and the importance of them, they will remain disciplined forever.

Here children must be made aware by parents of the need to balance the use of gadgets with their studies and sports, and giving examples of players like MS Dhoni who are popular because of their discipline. Discipline ingrained since childhood will last forever.

Q19. You are professor as well as a social activist. There is an educated and well employed couple in your vicinity who often fight on their personal issues. One day they started fighting as usual, starting from arguments, turning loud, slamming doors and finally the male partner resorting to physical violence, the cry of wife and children started coming out. People come out, but do not dare to go to them citing that it is their personal matter, so any interference would be unethical and uncalled for. Answer the following questions based on the above case:

- Would you agree to be a bystander on the advice of the people that it is a personal matter of the couple? Give reasons.
- Suppose you go to the flat of the couple and enquire what is wrong but the male member insists that they be left on their own as it is their personal matter and you should mind your own business. What would be your reaction?
- Can police help in curbing this social malady by using legal authority and provisions?
- What is your moral and ethical locus standi on intervention of neighbours to stop the domestic violence?

(250 Words) (20 Marks)

a) It will be unethical for me to remain a spectator to such an immoral act. Hence I would not agree to be a bystander because:

- As a professor, it is my duty to stand for morals and ethics in society.
- As a social activist, I must ~~face~~ fight the crimes in society.
- I cannot allow the dignity of a woman and the innocence of children to be lost because others believe it as a 'private affair'.

b) In such a case, I will firmly stand my ground and ask the male member to mend his ways towards his family.

I will ask the woman to freely stand against her husband ~~so~~ without any fear. If the lady member agrees, I would offer them a last chance at peaceful resolution of dispute, failing which I will call the police instantaneously.

In this, I will reject his contention that it is a private affair because it threatens the life of a woman and ~~can~~ morality of whole society.

c) Police has a huge role to play in curbing such social malices as,
 i) They can create deterrence among wrongdoers.

 iii) Uphold the law of the land.

However, police's role is only post crime, and only if the society or the victim reports it, without which it can't act.

d) I believe that neighbours have a crucial responsibility on their shoulders to ensure peace and social justice. And those who shirk this responsibility are unworthy neighbours.

Moreover, as nuclear families are increasing, neighbours play a crucial role in ensuring the moral strengthening of young couple's relationships.

School principal had his residence in the school premises only. The principal used to attend and participate in the daily morning prayers and take his two meals along with students. He was a kind hearted and empathetic person who used to provide also the moral education. The students liked and admired him because not only he preached, he used to set personal examples.

On the basis of above, answer the following questions:

- (a) What could be contribution of school principal in attitude formation of the students?
(b) If one of the students gets into civil services at a later stage, what impact and influence does the school will make on his attitude and behaviour?

The case study deals with attitude formation, and importance of role models.

a) School principal played a crucial role in attitude formation of students in following ways:

i) Attitude of gratefulness was cultivated by him through his act of prayers.

ii) Attitude of humility by having meals with his students.

- iii) Attitude of consistency by following a disciplined routine everyday.
- iv) Morally strong character through his moral education.
- v) Attitude of leadership by setting examples for his students and leading to integrity.
- b) A student who enters civil service will have huge impact of this school because,
- i) He/she will know the importance of being responsible, being brought up in a residential school.
 - ii) Principal's conduct would lead to integrity, impartiality and humility in the candidate.

Remarks

- iii) Student will be of morally strong character, leading to honest civil servant.
- iv) He/she will show greater sharing and learning capability which will lead to an attitude of abundance mentality.
- v) Humility would lead to attitude of gratitude, and a positive outlook
